

Town of Willing Board Meeting  
August 10<sup>th</sup>, 2015

The Monthly board meeting of the Town of Willing, County of Allegany and the State of New York, was held at the Town Hall, 1431 State Rt. 19 South, Wellsville NY on July 13<sup>th</sup>, 2015 at 7pm.

**PRESENT:** Supervisor Wightman, Councilwoman Roeske, Councilmen: Wiedemann, Fanton and Cook Superintendent Matteson , Clerk Buchholz and Security Officer Howe

Meeting was called to order by Supervisor Wightman at 7:00pm, all rose for the Pledge of Allegiance.

**REPLACEMENT OF 2000 CATIPILLAR PAYLOADER;** The board discussed in detail whether to buy straight out a new loader, use a buy back option or due nothing. At this time the tires all need to be replaced at a cost of ½ the worth of the pay loader at this time. The decided that due to the large amount of money needed they should have a financial plan in place before making a decision. A work session has been scheduled for Monday August 24<sup>th</sup>, 2015 at 7pm to discuss further.
